#### Your obligation to instruct

According to the german "Arbeitsschutzgesetz (ArbSchG)" and "DGUV-Vorschrift 1" employers are obligated to instruct their employees at least once a year. This instruction must contain all identifiable operational hazards and required protective measures to prevent these hazards.

Electrically instructed persons (EiPs) must be instructed at least once a year.
